ORDER


THIS CAUSE comes before the Court upon consideration of Brinkley Morgan's Unopposed Motion to Withdraw as Counsel of Record for Defendant Barry M. Rybicki. (Dkt. 71) Therein, Attorney Mark Andrew Levy, of the law firm Brinkley Morgan, advises that "Brinkley Morgan has not received any payments from or on behalf of Mr. Rybicki, including the funds unfrozen by the Court for payment of Mr. Rybicki's legal fees," and he requests the Court's permission to withdraw as counsel for Defendant Rybicki because "Mr. Rybicki has terminated Brinkley Morgan's engagement." Rybicki retained new counsel, Adam S. Fels, of the law firm Fridman Fels & Soto, PLLC, who entered his appearance in this action on April 1, 2020. (Dkt. 70)

Accordingly, upon consideration of the foregoing, it is hereby **ORDERED** that:

1. Brinkley Morgan's Unopposed Motion to Withdraw as Counsel of Record for Defendant Barry M. Rybicki, (Dkt. 71), is **GRANTED**;
2. The Clerk is directed to **TERMINATE** Mark Andrew Levy, of the law firm Brinkley Morgan, as counsel of record and recipient of filings for Defendant Barry M. Rybicki.
