**RECEIVER’S NOTICE OF LACK OF BONA FIDE OFFERS  
REGARDING THE SALE OF  
3914 ½ NORTH RIDGE AVENUE, TAMPA, FLORIDA**

On April 1, 2021, Burton W. Wiand, as Receiver (the “**Receiver**”) over the assets of the above-captioned corporate defendants and relief defendants,<sup>1</sup> filed the Receiver’s Verified Unopposed Motion to Approve Private Sale of Real Property — 3914 ½ North Ridge Avenue, Tampa, Florida (Doc. 285) (the “**Motion**” and the “**Property**”). A notice of the proposed sale was attached as Exhibit 5 to the Motion (the “**Notice of Sale**”). On April 4, 2021, the Notice of Sale was published in The Tampa Bay Times, which is a newspaper that is regularly issued and of general circulation in the district where the Property is located. An affidavit of publication for the Notice of Sale is attached hereto as Exhibit 1.

As indicated in the Motion, the Receiver files this notice to inform the Court that pursuant to 28 U.S.C. § 2001(b), no “bona fide offers” have been received. The Court issued an order granting the Motion (Doc. 286) and

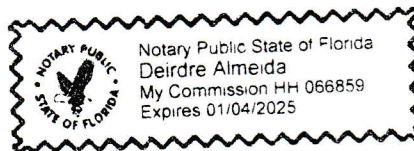
