**ORDER**

**THIS CAUSE** comes before the Court for consideration of Receiver's Unopposed Motion to Approve Sale of Personal Property – 2018 Pagani Huayra (the "Motion"). (Dkt. 326) The Receiver seeks the Court's approval to sell a 2018 Pagani

Huayara Roadster, VIN: ZA9H12UA3JSF76050, (the “Pagani”) to Miller Motorcars. (Id.) The Receiver also requests that the Court waive the requirements of 28 U.S.C. § 2001, to the extent that § 2001 applies to this sale. (Id.) Specifically, the Receiver seeks to sell the Pagani without obtaining any appraisals or publishing a formal legal notice. (Id.) Neither the Securities and Exchange Commission nor Defendants Brian Davison and Barry Rybicki oppose the Motion. Upon consideration of all relevant filings, case law, and being otherwise fully advised, the Court hereby **ORDERS** as follows:

1. The Receiver’s Motion, (Dkt. 326), is **GRANTED**.
2. The Court authorizes the Receiver to proceed with the sale of the Pagani to Miller Motorcars for \$2,300,000, without obtaining any appraisals or publishing a formal legal notice. The Court finds that this sale is commercially reasonable and in the best interest of the Receivership Estate.
