ORDER

THIS CAUSE comes before the Court for consideration of the Receiver's Unopposed Motion to Approve Transfer of Title to the Property Located at 5001 8th Avenue North, St. Petersburg, Florida 33710 (the "Property"). (Dkt. 382) At the request of the Securities and Exchange Commission ("SEC"), the Court appointed the Receiver on February 14, 2020 and directed him, in relevant part, to "[t]ake immediate possession of all property, assets and estates of every kind of the Corporate Defendants and Relief Defendants," which includes "all real property of the Corporate Defendants and Relief Defendants, wherever situated, and to administer such assets as is required in order to comply with the directions contained in this Order." (Dkt. 11)

The Court previously approved the sale of the Property as part of an auction conducted by the Receiver. (Dkt. 349) The Property was sold at auction to Paul Chadha, and the Receiver requests that the Court approve the transfer of title of the Property to Paul Chadha. (Dkt. 382) The SEC and Defendants Brian Davison and Barry Rybicki concur in the Motion. (*Id.* at 3) The Receiver provides the Sale Procedures Agreement for the Property for the Court's review. (Dkt. 382-1)

Accordingly, it is hereby **ORDERED AND ADJUDGED** that:

1. The Receiver's Motion, (Dkt. 382), is **GRANTED**.
2. Transfer of title to the Property located at 5001 8th Avenue North, St. Petersburg, Florida 33710, better known as Pinellas County Property

Appraiser's Parcel Id Number (PIN): 16-31-16-21402-000-0050, to Paul

Chadha is **APPROVED**. The Property's legal description is as follows:

Lot 5, Replat of Disston Manor Sub-Div., according to the map or plat thereof, as recorded in plat Book 27, page(s) 40, of the Public Records of Pinellas County, Florida.

3. Said transfer shall be free of any and all liens and encumbrances.
