<u>ORDER</u>

THIS CAUSE comes before the Court for consideration of the Receiver's Unopposed Motion to Approve Transfer of Title to the Property Located at 7503 S. Morton Street, Tampa, FL 33616 (the "Property"). (Dkt. 384) At the request of the Securities and Exchange Commission ("SEC"), the Court appointed the Receiver on February 14, 2020 and directed him, in relevant part, to "[t]ake immediate possession of all property, assets and estates of every kind of the Corporate Defendants and Relief Defendants," which includes "all real property of the Corporate Defendants and Relief Defendants, wherever situated, and to administer such assets as is required in order to comply with the directions contained in this Order." (Dkt. 11)

The Court previously approved the sale of the Property as part of an auction conducted by the Receiver. (Dkt. 349) The Property was sold at auction to Justin T. Stokes, and the Receiver requests that the Court approve the transfer of title of the Property to Justin T. Stokes. (Dkt. 384) The SEC and Defendants Brian Davison and Barry Rybicki concur in the Motion. (<u>Id.</u> at 3) The Receiver provides the Sale Procedures Agreement for the Property for the Court's review. (Dkt. 384-1)

Accordingly, it is hereby **ORDERED AND ADJUDGED** that:

- 1. The Receiver's Motion, (Dkt. 384), is **GRANTED**.
- Transfer of title to the Property located at 7503 S. Morton Street, Tampa, FL 33616, better known as Hillsborough County Property Appraiser's Parcel Id Number (PIN): A-20-30-18-42J-000193-00002.0 (Folio: 139128-

0000), to Justin T. Stokes is APPROVED. The Property's legal description

is as follows:

PORT TAMPA CITY MAP LOT 2 & E 1/2 CLOSED ALLEY ABUTTING THEREON BLOCK 193

3. Said transfer shall be free of any and all liens and encumbrances.
