**RECEIVER'S UNOPPOSED MOTION FOR EXTENSION
TO FILE QUARTERLY STATUS REPORT**

Burton W. Wiand, as Receiver (the "Receiver"), respectfully moves the Court to extend the deadline for filing the Receiver's Seventh Quarterly Status Report ("Status Report") to November 15, 2021. In support thereof, the Receiver states as follows:

1. Pursuant to the Order Appointing Receiver [Doc. 11], entered by the Court on February 14, 2020, Quarterly Status Reports are to be submitted within thirty (30) days of the end of the quarter. Doc. 11 at ¶28.

2. On July 30, 2021, the Receiver filed his Sixth Quarterly Status Report [Doc. 352], which detailed the Receiver and his team's activities for the second quarter of 2021. The Status Report for the third quarter of 2021 is due November 1, 2021.

3. The Receiver and his team are preparing the Seventh Quarterly Status Report but need some additional time to finalize the report for the Court.

4. This motion is not made for purposes of delay, and the relief requested will not prejudice any party.

WHEREFORE, the Receiver respectfully requests an extension of the deadline for filing of the Receiver's Seventh Quarterly Status Report to November 15, 2021.
