**RECEIVER’S NOTICE OF LACK OF BONA FIDE OFFERS

On November 17, 2021, Burton W. Wiand, as Receiver (the “**Receiver**”) over the assets of the above-captioned corporate defendants and relief defendants,<sup>1</sup> filed the Receiver’s Verified Unopposed Motion to Approve Private Sale of Real Property — 8105 West Gulf Boulevard, St. Pete Beach, Florida (Doc. 442) (the “**Motion**” and the “**Property**”). The Motion has been granted (Doc. 446).

A notice of the proposed sale was attached as Exhibit 5 to the Motion (the “**Notice of Sale**”). On November 21, 2021, the Notice of Sale was published in The Tampa Bay Times, which is a newspaper that is regularly issued and of general circulation in the district where the Property is located. An affidavit of publication for the Notice of Sale is attached hereto as **Exhibit 1**. As indicated in the Motion, the Receiver files this notice to inform the Court that pursuant to 28 U.S.C. § 2001(b), no “bona fide offers” were received.
