# **UNOPPOSED MOTION FOR EXTENSION OF TIME**

Defendant, Brian Davison, pursuant to Rule 3.01(c) of the Local Rules for the Middle District of Florida, files this Unopposed Motion for Extension of Time to respond to Receiver's Verified Motion for An Order to Show Cause Why Brian Davison Should Not Be Held In Contempt For Failure To Comply With The Court's Orders (Doc. 587) (the "Motion"), filed June 27, 2022. Under Local Rule 3.01(c), Defendant's response to the Motion is due on Monday, July 11, 2022.
