**ORDER**

**THIS CAUSE** comes before the Court for consideration of the Receiver’s Unopposed Motion to Approve Transfer of Title to the Property Located at 3307 N. Morgan Street, Tampa, Florida 33603 (the “Property”). (Dkt. 1250) At the request of the Securities and Exchange Commission (“SEC”), the Court appointed the Receiver on February 14, 2020 and directed him, in relevant part, to “[t]ake immediate possession of all property, assets and estates of every kind of the Corporate Defendants and Relief Defendants,” which includes “all real property of the Corporate Defendants

and Relief Defendants, wherever situated, and to administer such assets as is required in order to comply with the directions contained in this Order.” (Dkt. 11)

The Court previously approved the sale of the Property as part of an auction conducted by the Receiver. (Dkt. 977) The Property was sold at auction to Damir Mujkic, and the Receiver requests that the Court approve the transfer of title of the Property to Damir Mujkic. (Dkt. 1250) The SEC consents to the relief sought in the Motion and has waived any right to appeal this Order. (Id.) The Receiver provided the Terms and Procedures for Closing Auction Purchases for the Court’s review. (Dkt. 1250-1)


Accordingly, it is hereby **ORDERED AND ADJUDGED** that:

1. The Receiver’s Motion, (Dkt. 1250), is **GRANTED**.
2. Transfer of title to the Property located at 3307 N. Morgan Street, Tampa, Florida 33603, better known as Hillsborough County Property Appraiser’s Parcel Id Number (PIN): A-12-29-18-4IA-000020-00004.0 (FOLIO: 168238-0000) to Damir Mujkic is **APPROVED**. The Property’s legal description is as follows:

**CENTRAL PARK BLKS 13 14 15 16 17 19 20  
AND 21 LOT 4 BLOCK 20**

3. Said transfer shall be free of any and all liens and encumbrances.
